Education Mission Statement



SPEAKERS



MATHEW M. AVRAM, M.D., J.D.

Dr. Avram is the director of the Massachusetts General Hospital Dermatology Laser Director for Laser and CosmeticTraining in the Department of Dermatology, Harvard Medical School. Dr. Avram has also been

elected to the Board of Directors of the American Society for Dermatologic Surgery (ASDS) and also serves as Treasurer for the American Society for Laser Medicine Surgery (ASLMS), where he is also is a member of Executive Committee. Dr. Avram was the Program Co-Chair of the 2010 ASLMS annual meeting in Phoenix, Arizona. Dr. Avram has also served as Co-Chair for an annual laser teaching session for four years for the FDA in Silver Spring, Maryland. He has served as Co-Chair of the Cutaneous Laser Surgery Section of the ASLMS meeting in 2009, 2011 and will do so again in 2015. He is co-author of the First and Second Editions of A Color Atlas of Cosmetic Dermatology published by McGraw-Hill (which has been translated into 5 languages) as well as its "I-phone app." He is coeditor of Lasers and Lights, a textbook published by Elsevier and Laser & Light Source Treatments for the Skin by Jaypee. He has published 50 peer-reviewed papers in each of the New England Journal of Medicine, the Journal of the American Academy of Dermatology, JAMA Dermatology, Lasers in Surgery & Medicine and Dermatologic Surgery as well as other journals as well as multiple chapters in leading dermatology textbooks. He is co-director of the MGH/Wellman Laser & Cosmetic Fellowship, where he has trained 17 fellows to date. He is an affiliate faculty member of the Wellman Center for Photomedicine. He is an associate editor of the Journal of Cosmetic and Laser Therapy. He serves on the Editorial Boards of Lasers in Surgery & Medicine, Dermatologic Suraerv and Lasers in Medical Science. He also serves on the Surgical Advisory Board of JAMA Dermatology. Dr. Avram is a frequent quest on the Dr. Oz show, ABC, NBC, CBS, FOX and has appeared multiple times in the New York Times, Wall Street Journal, Washington Post, and numerous other media. Dr. Avram has chaired 19 national meetings and has given over 300 invited lectures at national and international meetings. Dr. Avram attended college at Princeton University and completed his dermatology residency training at Harvard, where he served as chief resident. Subsequently, he completed his Mohs micrographic surgery, laser & cosmetics fellowship at UCLA.



PETER HEALD, MD

Dr. Peter Heald had developed a career on the faculty of Yale School of Medicine that was based on dealing with cutaneous lymphoma, with complicated dermatology referrals, and with teaching derma-

tology to students, residents, physicians and anyone else who would listen. Currently Dr. Heald sees consultations part time, teaches at the dermatology programs of Yale and University of Connecticut. For continuing education, he frequently lectures on topics pertaining to the integration of new therapies into the treatment of skin diseases. Five of the therapies that Dr. Heald did research on reached final approval by the FDA. In the past two years, Dr. Heald and Dr. Subtil have published descriptions of two new distinct variants of cutaneous lymphoma. In addition to trying to advance understanding of cutaneous lymphomas Dr. Heald has tried to understand the problems that arise in the practice of dermatology by interacting with the Connecticut dermatology community.



OMAR IBRAHIMI, MD, Ph.D.

Dr. Omar Ibrahimi is the medical director of the Connecticut Skin Institute. He completed his Dermatology training at Harvard Medical School and a fellowship program in Mohs and Reconstructive Surgery, Laser and Cosmetic Surgery at the University of

California – Davis. He is well known nationally having been an invited speaker at numerous national meetings, and written extensively about Mohs Surgery, Laser and Cosmetic Procedures. Dr. Ibrahimi has published over 65 research articles and book chapters on skin cancer surgery, laser and cosmetic procedures in leading medical journals. He has also performed thousands of cases of Mohs Surgery and Laser and Cosmetic procedures. Dr. Ibrahimi previously served as a Visiting Assistant Professor of Dermatology at Harvard Medical School in the Wellman Center for Photomedicine. The Wellman Center for Photomedicine is the world's leading research center where the majority of today's laser and cosmetic technologies were invented and tested. He is an active participant in many clinical trials of new technologies.



JOSEPH MEROLA, M.D., Ph.D.

Dr. Merola received his MD from the NYU School of Medicine and MMSc from Harvard Medical School. He is one of a handful of individuals in the country boarded in internal medicine, dermatol-

ogy and rheumatology. He completed dermatology training and was chief resident at the NYU School of Medicine. He trained in internal medicine and rheumatology at the Brigham and Women's Hospital. He is an instructor at Harvard Medical School. He currently serves as the director of clinical trials for the Department of Dermatology, is co-director of the center for Skin and Related Musculoskeletal Diseases and the assistant program director for the combined internal medicine-dermatology residency training program. His clinical and research interests are focused on autoimmune diseases of the skin and joints including psoriasis / psoriatic arthritis and lupus.
