Lisa M. Donofrio is a graduate of Quinnipiac University and Tulane University School of Medicine, USA. She completed an internship in Internal Medicine and a residency in Dermatology at Tulane where she also served as Chief Resident. While at Tulane, Dr Donofrio trained with renowned instructors in the fields of dermatologic and cosmetic

surgery, and was recipient of the Peterkin Award for excellence in research.

Dr. Donofrio is board certified in Dermatology and is in private practice at the Savin Center for Dermatology and Cosmetic Surgery in New Haven. Dr. Donofrio doesn't limit herself to Connecticut. She started her latest practice in New Orleans and has been performing her unique services in New York City. She is an Associate Clinical Professor of Dermatology at Yale University School of Medicine and an Assistant Clinical Professor of Dermatology at Tulane University School of Medicine. Dr. Donofrio is an assistant editor of the Journal of Dermatologic Surgery and is an active member of the American Society for Dermatologic Surgery serving as a board member and Chair of the 2007 Annual Meeting. Dr Donofrio is also a member of the American Society of Liposuction Surgery and a fellow of the American Academy of Dermatology.

Dr. Donofrio has conducted cancer research at Yale Medical School in the departments of Pathology and Therapeutic Radiology, and has several publications on structural fat transfer, liposuction, fillers and surgical technique. She is a frequent lecturer and invited speaker at numerous international and domestic dermatology and surgery meetings.

#### JUSTIN FINCH, M.D.

Justin Finch is an Assistant Professor of Dermatology and the Director of the Center for Laser Surgery at UConn. He received his medical degree from the University of Minnesota and completed his dermatology residency at UConn. Outside of the clinic, Dr. Finch's interests include camping, backpacking, and photography. He has an extensive background in photography, and was a wedding photographer before he went to medical school.



#### CARRIE KOVARIK, M.D.

Dr. Kovarik is an Assistant Professor of Dermatology, Dermatopathology, and Infectious Diseases at the University of Pennsylvania. Dr. Kovarik has a special interest in tropical, infectious, and HIV-related dermatology. Dr. Kovarik completed the Gorgas Course in Clinical Tropical Medicine in 2005, obtained the American Society of Tropical Medicine and Hygiene (ASTMH) Certificate of Knowledge in Clinical Tropical Medicine and Travelers' Health in 2006. Dr. Kovarik is the Head of Dermatology, Informatics, and Telemedicine for the Botswana-UPenn Partnership and is the primary dermatology consultant

for the Baylor International Pediatrics AIDS Initiative (BIPAI) in Africa. Dr. Kovarik has created an African teledermatology consult service (africa.telederm.org) which is a collaborative effort between BIPAI, the American Academy of Dermatology, twelve African countries, and several other institutions. She has also been working to expand telemedicine services in Africa and Central America through the use of cellular phones. Dr. Kovarik has started an initiative in global health at the University of Pennsylvania, and she is the Director of the Penn Dermatology Global Health Program. Dr. Kovarik is also the Chair of the Residents' International Grant Work Group within the AAD and received funding to send over 80 senior dermatology residents in 2008-2014 to participate in 4-6 week rotations on the dermatology consult service in Botswana.
